I understand that in submitting the Permit Application that I am responsible for installing, equipping, operating, and maintaining the well in a manner that complies with District Rules and State Law. This includes the responsibility of informing the water well driller of the Proposed Well Site and drilling the proposed well no more than ten (10) yards from the Proposed Well Site. I further understand that if the well must be plugged, closed, or capped that it is my responsibility to do so in accordance with State Law.

I understand that in submitting this Permit Application I am subject to the Rules of the District, that I will read the Rules of The District, and I understand that any violations of the Rules is enforceable by the District Board of Directors in a manner as described under Rule 2.11.

I understand that by submitting this Permit Application, I am granting the District the right to use this site as an observation well.
